Patient Authorization and Consent to Treatment:

I consent and/or authorize the employees and agents of Tanner Medical Group (TMG) to perform such diagnostic or screening examinations, tests, procedures, or services and to provide any medications, care, treatment, services or therapy necessary to effectively assess and maintain my health and to assess, diagnose and treat my illness or injuries as ordered by the treating provider(s). I understand that I have the right to be informed about my condition and the recommended surgical, medical or diagnostic procedure to be used so that I may make the decision whether or not to undergo any suggested treatment or procedure after knowing the risks and hazards involved. I have the right to discuss the treatment plan about the purpose, potential risks and benefits of any test ordered. I understand that if additional testing, invasive or interventional procedures are recommended, I will be asked to read and sign additional consent forms prior to the test(s) or procedure(s). I understand that students under the supervision of a physician may be involved with patient care. I understand that I may be seen by either a physician, physician's assistant, or a nurse practitioner at Tanner Medical Group.

I understand that TMG participates in a secure Health Information Exchange (HIE). The HIE supports integrated system patient care initiative by allowing physicians and healthcare providers to share and access patients' health information through an HIE for treatment, payment, and health care operations purposes. I understand that I have a right to opt out of having my information available in the HIE by signing an Opt-Out form.

I understand that as part of the HIE, I have the right to elect to participate in Tanner MyChart Patient Portal to obtain secure access to my personal patient information.

Guarantor Financial Agreement

Financial Agreement: I acknowledge, that as a courtesy, the practice may bill my insurance company for services provided to me. Third Party Collection: I acknowledge the practice may use the services of a third-party business associate or affiliated entity as an extended business office (“EBO Servicer”) for medical account billing and servicing.

Workers Compensation: If your injury is work-related, we will need to verify coverage and request the case number and carrier name prior to your visit to bill the worker’s compensation insurance company. Otherwise, you will be responsible for all charges.

Assignment of Benefits: I hereby assign to the practice any insurance or other third-party benefits available for health care services provided to me. I understand the practice has the right to refuse or accept assignment of such benefits. If these benefits are not assigned to the practice, I agree to forward all health insurance or third-party payments that I receive for services rendered to me immediately upon receipt.

Medicare Patient Certification and Assignment of Benefit: I certify that any information I provide, if any, in applying for payment under Title XVIII (“Medicare”) or Title XIX (“Medicaid”) of the Social Security Act is correct. I request payment of authorized benefits to be made on my behalf to the practice by the Medicare or Medicaid program.
